- 2) Leasee shall not use the premises for any unlawful purpose. Leasee shall not under any circumstances assign this lease, or sub lease or grant any license or permit other than parties to use the premises. Leasee agrees not to commit or permit waste or damage to any part of the building fixtures or personal property contained on or within the premises. NO GAMBLING OF ANY KIND IS OERMITTED ON THE PREMISES.
- 3) Leasee is responsible for the setting up and arrangement of tables, chairs, ect. During their possession time in the rental agreement. Leasee is responsible for returning to storage all chairs and tables acquired from storage prior to leaving the facility. There will be a \$35.00 restoring fee deducted from the security deposit should the GAC is required to restore any and all items.

Leasee shall surrender the premises to the GAC in as good a condition as it was received, and agrees to be responsible for and pay to the GAC the full cost of any repair or replacement of any property which is damaged, destroyed, lost or stolen due directly or indirectly to the use of the premises by the leasee. The GAC shall apply the deposit to the cost of repair or replacement of the property, and shall refund to the amount of the deposit, if greater than the cost of repair or replacement.

4) All personal property belonging to the leasee or any other person, located in or about the leased premises, shall be left there at the sole risk of the leasee or other such person, and neither the GAC nor the GAC officers, board members, membership, or employees shall be liable for the theft, misappropriation, misuse, or loss thereof, nor any damage or injury thereto caused in any manner whatsoever. Leasee will protect, indemnify and hold harmless the GAC, it's officers, membership and employees from all losses, claims, damages, suits or whatsoever, due directly or indirectly to the use of the leased premises, or any part thereof by leasee.

- 5) If the leasee engages the services of a photographer, caterer, band, musicians, disc jockey or any other entertainment or services, The GAC must be informed at least ten business days, in advanced of the event for which the premises has been leased. Any photographer, band, musicians, disc jockey or any other entertainment or services, must provide their own equipment and may not use any equipment belonging to the GAC. Any damage resulting from such misuse caused by photographer, caterer, band, musicians, disc jockey or any other entertainment or services, shall be paid for in full by the leasee.
- 6) Attached hereto as Appendix A, and made part of this lease, is a copy of the GAC rules and regulations governing the use and occupancy of the leased premises. Leasee hereby acknowledges receipt of and has read and understands such rules and regulations. Leasee agrees to comply with all provisions of such rules and regulations, and that any violation thereof or any term or condition of this lease, is cause for immediate termination of this lease.

Appendix A

Guild Athletic Club Rules and regulations Governing The Use And Occupancy of GAC Leased Premises:

6A) Leasee agrees to vacate premises at the exact time specified in the lease. If the leasee fails to vacate premises as agreed, an additional charge will be assessed for the time during which it is occupied after the said period has elapsed.

6B) Security deposit as stated is paragraph I of this contract shall be made when the lease is signed, and no part of the security deposit may be applied to the rental fee.
6C) Leasee shall not have any use of any other part of the building other than that part referred to as the main hall, restrooms, coat room, bar area, kitchen, catering area, and storage room in the mail hall.

THE LOWER LEVEL AND BASEMENT IS OFF LIMITS.

6D) No gambling of any kind is allowed on the premises

6E) Leasee shall be responsible for securing and locking all doors and turning off all lights.

6F) Firearms are strictly prohibited on the premises.

- 6G) Alcoholic beverages, liquor, beer, wine, ect., may not be sold on these premises
- 6H) No decorations are to be pinned, nailed or taped to any wall mirror or woodwork in the bar area. Decorations are permitted in the main hall restricted to the hooks, nails and fasteners provided.
- 6I) Maximum occupancy permitted is 150 people

6J) Cost of hall rental.



6a) Use of the GAC Kitchen.

Kitchen Rental Guidelines - Cleanup

Wipe off all counters, stoves and appliances which were used during cleaning up

Sweep kitchen floor

Check stove before leaving to ensure that all gas pilots are burning. Ensure the ovens are turned off

Empty all trash in the kitchen before leaving, placing at or in dumpster

Remove all Items from storage / refrigeration brought into the kitchen for the event for which rented. Remove any food items from all ovens and cook tops.

Remove & take all food items both from the ovens and refrigeration

Turn off lights ~ Lock rear kitchen door
